- Represents grant of RSUs under the Issuer's Omnibus Equity Incentive Plan granted August 15, 2021.
- One quarter of the RSUs vested on August 15, 2022 and the remainder will vest quarterly over the following three years, in each case subject to continued employment with the Issuer through each vesting date.
